
## Individual Narrative of Cornelia<sup>7</sup> L. Devoe [170] Daughter of Frederick Devoe and Sarah<sup>6</sup> Leverich [63]

Cornelia L. Devoe was born on 28 Feb 1812 at Bushwick, Kings Co, New York, the daughter of Frederick Devoe and Sarah Leverich. Cornelia was likely baptized at the Bushwick Reformed Church in Kings Co, New York, as were several of her siblings. However, a baptismal record for Cornelia has not been found.<sup>1,2</sup>

In the years 1828-1829 Frederick Devoe and his wife Sarah Leverich executed six deeds granting lands in his Williamsburgh estate to various of their surviving children, "in consideration of the love and affection which they have and bear toward the grantee, as well as the receipt of \$1.00." One of these deeds, dated 13 March 1829, granted land to their daughter Cornelia L. Devoo. The deed was recorded 21 March 1829.<sup>3</sup>

Cornelia L. Devoe died unmarried on 13 Aug 1831 at Williamsburgh, Kings, New York, at age 19. Cornelia was buried at the Bushwick Reformed Church graveyard. On 7 April 1851, she was reinterred at the Evergreens Cemetery in Brooklyn.<sup>4,5</sup>
