## Individual Narrative of Paul<sup>8</sup> Vandervoort Leverich [337] Son of Richard<sup>7</sup> Berrian Leverich [179] and Alletta Vandervoort

Paul Vandervoort Leverich was born on 1 June 1802 at Newtown, Queens County, New York.<sup>1</sup> Paul V. Leverich was baptized 30 July 1802 in the Newtown Presbyterian Church.<sup>2</sup>

On 10 January 1824 Paul V. Leverich, described as an insolvent debtor, had a bankruptcy hearing in Queens County, New York.<sup>3</sup>

Paul V. Leverich died on 2 April 1826 at Hurlgate, Queens County, New York, at age 23.<sup>4,5,6</sup> Paul was buried at the Leverich Family Cemetery in Jackson Heights, Queens County, New York.<sup>7</sup>

Paul V. Leverich was never married.
